Notice and Consent to Data Processing

1. <u>Introduction</u>

This Notice and Consent to Data Processing ("Notice") is designed to help you understand how ("Columbia," "Global Centers", "we," "us," or "our") will process the Personal Data it collects from you in connection with its sites for designed to provide opportunities to students, alumnae and other Columbia affiliates an opportunity to socialize, study and network.

For the purposes of the EU General Data Protection Regulation ("GDPR") and other privacy laws, the data controller is Columbia (*i.e.*, Columbia Global Centers or Centers for International Programs, LLC), located at 91 Claremont Ave, New York, NY 10027, USA.

2. Collection and Processing of Your Personal Data

The Global Centers will collect and process your Personal Data, which is information that may be used to identify you. In particular, "Personal Data" includes your first and last name, your email address, your UNI or unique identification number, your mobile telephone number, date and time that you visited a Global Center or WeWork site and your city and country of residence. We will only collect information that you voluntarily provide to Columbia.

3. How We Use Your Information

The Global Centers collects and Processes your Personal Data to support the efforts of the Global Centers and the WeWork sites to provide opportunities for Columbia students, alumnae and other Columbia affiliates to visit the various sites, to inform them about the networking, study and social opportunities available at various sites and to communicate with them about the specific site opportunities that may interest them. In some locations the Personal Data will be used to support health and safety endeavors, where permitted by law.

In the absence of such Personal Data, The Global Centers will not be able to provide the opportunities to network, study and socialize to the Columbia students, alumnae and other Columbia affiliates, nor maintain a safe and healthy environment.

4. Retaining and Deleting Your Personal Data

Columbia will retain your Personal Data only for a period of time that does not exceed the applicable statutory limitation periods.

5. Provision of Your Personal Data to Others

Columbia may provide Your Personal Data to third-party service providers that support us in our efforts to provide these opportunities.

6. <u>International Transfer of Your Personal Data</u>

By voluntarily providing the Personal Data described above to the Global Centers, you consent to the transfer of such information to the Global Centers and to Columbia's location in the United States. Please be aware that the United States may not guarantee the same level of protection for personal data as the country in which you reside.

7. Your Rights

Under the GDPR and certain additional privacy laws, you have a right to access, modify, rectify, limit, delete, and request the transfer of your Personal Data to your Personal Data. You also have the rights to restrict and object to the Global Centers' processing of your Personal Data.
