

# Request for Applications: Richard Rockefeller Fellowship at Columbia Global

## Overview

Columbia Global will host the Richard Rockefeller Fellowship (RRF) in 2025 to support the practical development of emerging leaders in China's philanthropic and non-government sectors as they explore strategic philanthropy for a sustainable future and strengthen collaborative ties between the U.S. and China in these areas.

This year's program, which will begin in July 2025, will empower a cohort of eight social entrepreneurs and nonprofit leaders from China, focusing on sustainable development and climate issues. Fellows will gain in-depth knowledge, skills, and networks to scale their organizations' initiatives and create lasting positive change.

The fellowship will span a duration of four to five months and include a range of program elements:

- **Onboarding and Cohort Strengthening:** Fellows will engage in an introductory phase that covers core topics, including a two-day "Creative Ideas" launch and the development of a draft action plan while in China.
- **A Five-Week Stay in the U.S.:** Fellows will benefit from a carefully curated educational and capacity-building experience at Columbia University and leading U.S. philanthropic organizations. This portion will focus on practical learning and tailored academic experiences that align with their interests and goals.
- **Comprehensive Expense Coverage:** The fellowship covers all essential expenses, including housing, meals, international airfare, training program tuition, insurance, materials, and other relevant program-related costs.
- **Year-Round Mentorship:** Fellows will be paired with experienced mentors who will offer guidance, expertise, and support throughout the program, enhancing their learning experience.
- **Expanded Networks:** Fellows will enjoy sustained networking opportunities with U.S. and Chinese colleagues to support their continued work in China.

- **Final Action Plan Presentation:** Fellows will finalize their action plans and present them to key stakeholders in China, ensuring that their insights and strategies are effectively communicated.

Throughout the program, fellows will engage with three core components: Personal Leadership Development, Strategic Philanthropy, and Climate Action and Solutions, each focused on equipping them with the tools and expertise to drive impactful change in their work.

**Requirements:** The RRF is an intensive, full-time fellowship that lasts approximately four to five months. Fellows should not undertake external work during their fellowships and should obtain a formal leave of absence from their current work for the duration of the fellowship.

During the program, fellows will be responsible for completing a set of activities and research objectives. Responsibilities include active participation in meetings and lectures, research, writing, and logistical and administrative coordination. Fellows will be asked to submit regular progress reports during the length of their stay.

**Required outputs:**

- A mid-term and final English-language report summarizing key insights from their experience, research, and their thoughts about how these insights can contribute to the development of strategic philanthropy in China;
- An internal presentation to Columbia Global leadership and staff on fellowship findings;
- A comprehensive action plan to key stakeholders in China, demonstrating newly acquired skills and knowledge while identifying sustainability and climate solutions tailored to the Chinese context;
- A minimum of two presentations on their fellowship experience upon return to China at the conclusion of the program.

## Covered Accommodations and Expenses

The Fellowship will provide a modest stipend and cover costs for housing, food, international airfare, program materials, local meetings, and travel costs, as well as other relevant program-related expenses. Fellows will have room and board consisting of single-room dorm accommodations with shared bath facilities.

Selected applicants must participate in the fellowship as individuals. We are unable to invite and/or cover expenses for significant others and/or family members to join the fellows in New York.

## Selection Criteria

**Baseline Requirements**

- Stage: Mid-career professionals at a pivotal point in their career journey

- Citizenship: A Chinese citizen (including those from Hong Kong and Macau)
- Education Level: Bachelor's degree or higher
- English Proficiency: Strong speaking and writing skills in English. This can be fulfilled by meeting at least one of the following criteria:
  - Holding an undergraduate or graduate degree from a country where English is an official language.
  - Providing scores from recognized English proficiency tests.
    - Accepted tests include the Test of English as a Foreign Language iBT (TOEFL) - including TOEFL iBT Home Edition and Paper-Based Test (PBT), International English Language Testing System Academic (IELTS), Pearson Test of English (PTE Academic), or Duolingo English Test (DET).
  - Demonstrating proficiency through other means, such as using English as the primary language for work, study, or daily living.
- Availability for Program
  - Are you committed to spending July to November 2025 participating in the RRF?
  - Are you committed to spending five weeks in September to October 2025 in the United States?
  - During the portion of the program when you are staying in the United States, do you agree to live in the program's pre-determined accommodations?

#### Criteria

- **Mission Alignment**
  - Demonstrates significant vision and the potential to become a social impact leader in China, with a strong commitment to sustainable development and addressing climate issues.
- **Personal Quality**
  - Optimistic, inquisitive, and open-minded, with the ability to work independently and collaboratively.
  - Approaches societal challenges with creativity, critical thinking, and cross-disciplinary perspectives.
- **Potential for Growth and Learning**
  - Demonstrates a strong desire to acquire new knowledge and skills to overcome current challenges (e.g., scaling impact, securing funding, refining strategy).
  - Actively seeks opportunities for personal and professional growth through academic and network resources.
  - Presents a realistic plan for applying new knowledge and skills to their work.
- **Skills & Experience**
  - Excellent communication, research, and writing skills in English.
  - Demonstrated track record of entrepreneurial or leadership experience in social enterprise, nonprofit, or impactful projects.

Please include the following materials **in English** with your online application:

- Personal Statement (200 words or fewer) addressing the following three questions:
  - Describe your current work as it relates to climate and sustainability.
  - What do you hope to focus on during the fellowship, and how does this relate to your current or future work?
  - Why is this moment the right time in your career to benefit from this program?

- Scanned copies of diplomas from all post-secondary institutions attended
- Resumé or Curriculum Vitae (three-page maximum)
- A one- to two-minute video answering the following question:
  - Your name, current work/study status.
  - What motivates you about your current work in climate and sustainability, and how would this program help you achieve your goals?
- Two letters of recommendation (**either in English or Chinese**) from individuals in academic, professional, or community service settings
- Applicants who have not earned their undergraduate or graduate degree from a country where English is the official and widely spoken language must provide evidence of English proficiency.
  - Acceptable documentation includes recognized test scores (e.g., TOEFL, IELTS, PTE, DET) or proof of significant professional experience where English was used as the primary language for communication, such as employment verification, written statements from employers, or transcripts from English-taught programs.
